



Conditions of Participation

Organizer

- 1.) Organizers of this playtest are the companies weltenbauer. and astragon Entertainment GmbH.
- 2.) The playtest will take place between **July 8, 2022 (6 PM CEST) and July 10, 2022 (11:59 PM CEST)**. The organizers retain the right to shorten or expand the stated time period at their own discretion.
- 3.) The playtest will take place using Steam™ by Valve Corporation. The playtest is only available on PC using the Steam™ client.

Eligibility

- 1.) Eligible are all persons from 18 years who own a PC and have an active Steam™ account.
- 2.) Registration may be made solely via online application using the form found on the following website: <https://forms.gle/t3LU2ssE94E5ZM379>. Written applications via direct messages on Social Media platforms, fax or e-mail will not be processed.
- 3.) Closing date is **July 3, 2022 at 23:59 (CEST)**.
- 4.) Both staff and the families of the staff of the companies involved are excluded from participation.
- 5.) Application does not entitle to participation. The organizers reserve the right to select participants. Participants will be notified via email on **July 7, 2022** the latest. We recommend to check the spam folder as well.
- 6.) Organizational activities will be communicated by the organizers towards the participants at the start of the playtest. The instructions of the organizers are to be followed without exceptions. In case of violation leading to a disturbance of the proper process of the playtest the organizers retain the right to exclude the concerning participant from the playtest at any time.
- 7.) Participation is a personal right and cannot be transferred.

Data protection declaration

- 1.) Any personal data submitted by the participant during registration will be saved and solely used for the implementation and execution of the playtest. Participants agree to this temporary data storage within these limits by registering.
- 2.) Participants agree to receive messages during the period of the playtest via e-mail solely to be informed about the playtest process.
- 3.) Gameplay progress and certain activities within the game will be recorded via **Google Analytics**, and used for the product's improvement. Please read the privacy statement for detailed information. You automatically agree to these terms by registering. The privacy policies can be accessed via the link in the google forms document.

Implementation and execution

- 1.) In case of the organizers being obliged to cancel or implement changes to the conduction of the playtest for important reasons, the organizers shall not be liable to pay damages to the participants.
- 2.) With his registration for the playtest the participant commits himself to accept the non-disclosure agreement (NDA). The non-disclosure agreement can be viewed during registration and commits the participant to keep all information received as strictly confidential. Furthermore, it is not permitted to create or disseminate screenshots, videos or live streams (e.g. Facebook, Twitch, YouTube, Mixer...).
